Sun Smart Policy

PURPOSE

To educate and guide parents, students and school staff in the adoption of sensible and consistent protection procedures at all school activities and events.

To assist in the development of lifelong habits of skin protection and to assist students to be increasingly responsible for their own sun protection.

Ensure all students and staff are well protected from too much UV exposure by using a combination of sun protection measures.

Ensure the outdoor environment is sun safe and provides shade for students and staff.

Support appropriate OHS strategies to minimise UV risk and associated harms for staff and visitors.

BROAD GUIDELINES

- 1. Sun protection is used from September to the end of April.
- 2. The program is designed to reduce the risk of skin cancer, by limiting exposure to the sun's ultraviolet radiation.
- 3. Protecting students from excessive exposure to ultraviolet radiation during school hours is the joint responsibility of students, parents/ guardians and school staff.
- 4. Programs to develop student awareness of the risks of overexposure to UV and the need to maintain appropriate Vitamin D levels are included in the Health curriculum.

IMPLEMENTATION

1. Seek shade

- The availability of shade is considered when planning all outdoor activities and excursions.
- In consultation with the school council, shade provision is considered in plans for future buildings and grounds.
- Students are encouraged to use available areas of shade when outside.

2. Slip on sun protective clothing

• Sun protective clothing is included in our school uniform / dress code. School clothing is cool, loose fitting and made of densely woven fabric. It includes shirts with collars and elbow length sleeves, longer style dresses and shorts. Rash vests or t-shirts for outdoor swimming are mandatory except when students are actually competing in an event.

3. Slap on a hat

- All students are required to wear hats that protect their face, neck and ears, i.e.
 legionnaire, broad brimmed or bucket hats, whenever they are outside including during
 recess, lunchtime, sport, excursions and camps. Baseball or peak caps and visors are
 not considered a suitable alternative.
- Students are responsible for looking after their hats at school.
- Students not wearing hats during recess, lunchtime, sport, excursions and camps are required to be in a designated shade area.

4. Slop on sunscreen

- Parents are responsible for providing their child's own SPF 30 or higher broad spectrum, water resistant sunscreen.
- Students are given the opportunity to apply sunscreen at least 15 minutes (where possible) before going outdoors and reapplied every two hours if outdoors. Teachers are not permitted to apply sunscreen to students.
- Students who have not applied sunscreen are reminded that they should play in a designated shade area.

5. Slide on sunglasses

• Where practical, students and staff may choose to wear close fitting, wrap-around sunglasses that meet the Australian Standard 1067 (Sunglasses: Category 2, 3 or 4) and cover as much of the eye area as possible.

Learning and skills

 SunSmart behaviour is regularly reinforced and promoted to the whole school community through newsletters, school homepage, parent meetings, staff meetings, school assemblies, student and teacher activities and on student enrolment.

Engaging children, educators, staff and families

- Staff and families are provided with information on sun protection through family newsletters, noticeboards and the school's website.
- As part of OHS UV risk controls and role-modelling, between April and September staff, families and visitors:
 - a. wear a sun protective hat, covering clothing and, if practical, sunglasses when outside
 - b. apply sunscreen
 - c. seek shade whenever possible
